There are 3 stages to the National Certification Program for Home and Property Inspectors in the NHICC:

- 1. Candidate the entry point into the National Certification Program
- 2. **Provisional** well in process, incomplete exams or inspections
- 3. National Home Inspector the completion of the National Certification Program
